- Our portal is aimed at being available for users, with the latest features added at the moment.

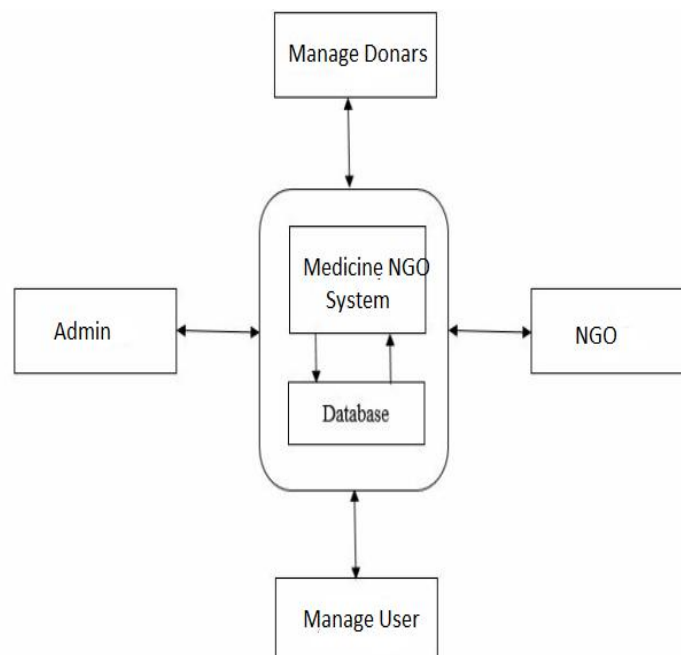
- By having an easy navigation system for users, the portal will become friendly, which will also make the users comfortable for donating and receiving medicines from NGOs.

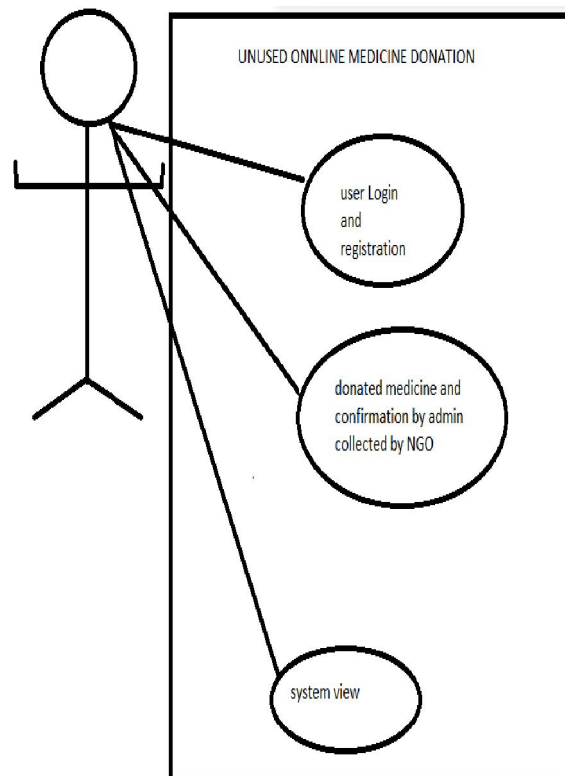
