II. RESEARCH METHODOLOGY

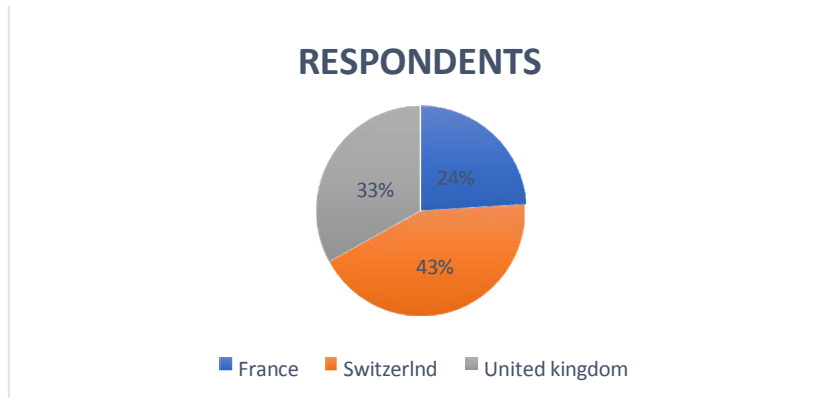

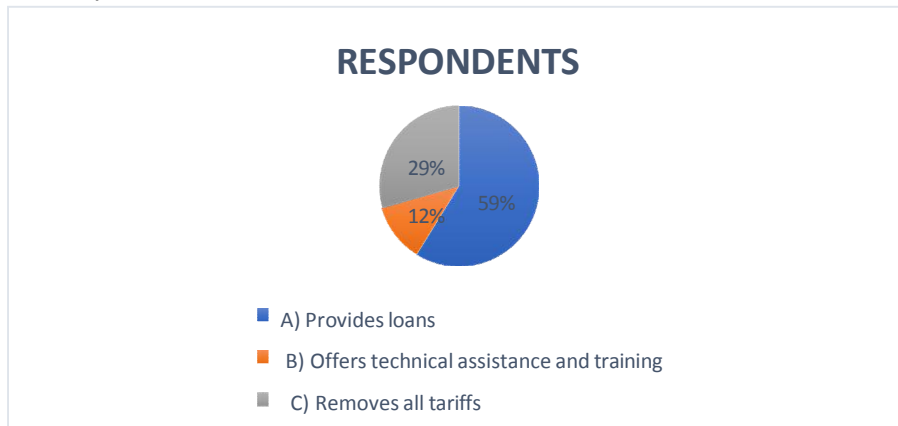
Research Results

How does the WTO support developing countries in Europe

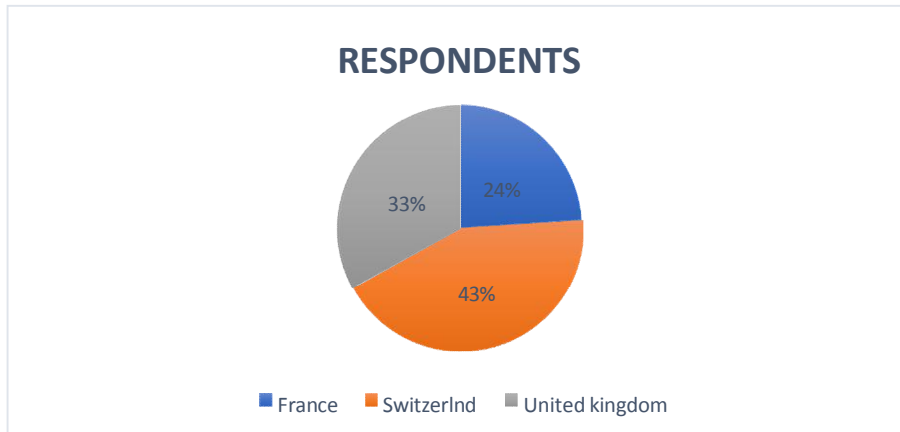


Fig: 2- Which European country is not a member of the WTO
