From the below mentioned interviewed questions above mentioned points were put forward:

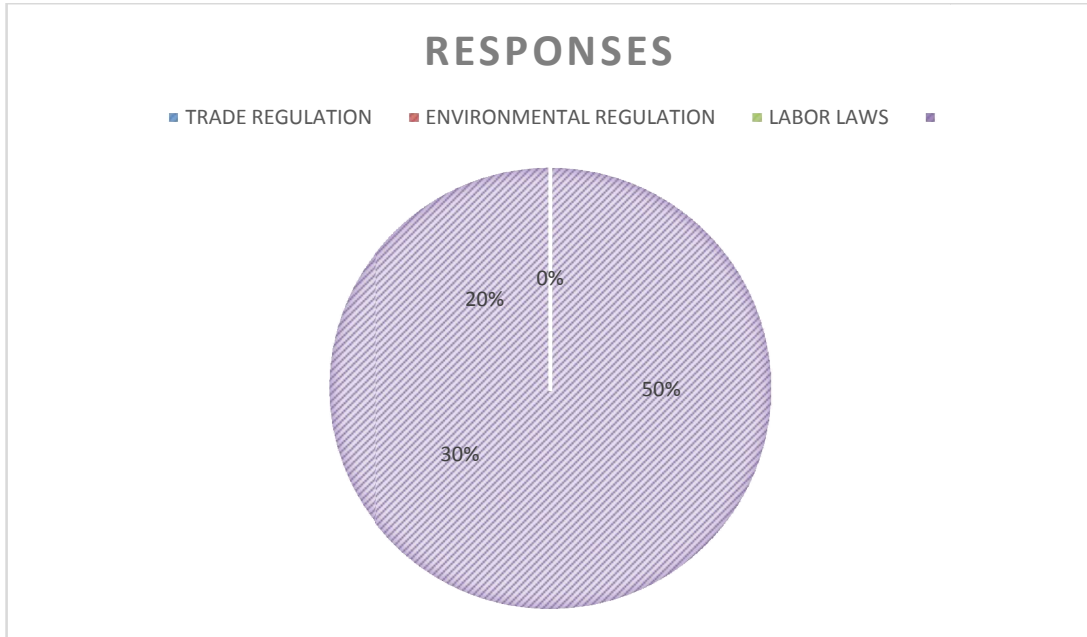


Fig 2 - Which area of international law do you believe most impacts Mahindra Pvt Ltd's operations?

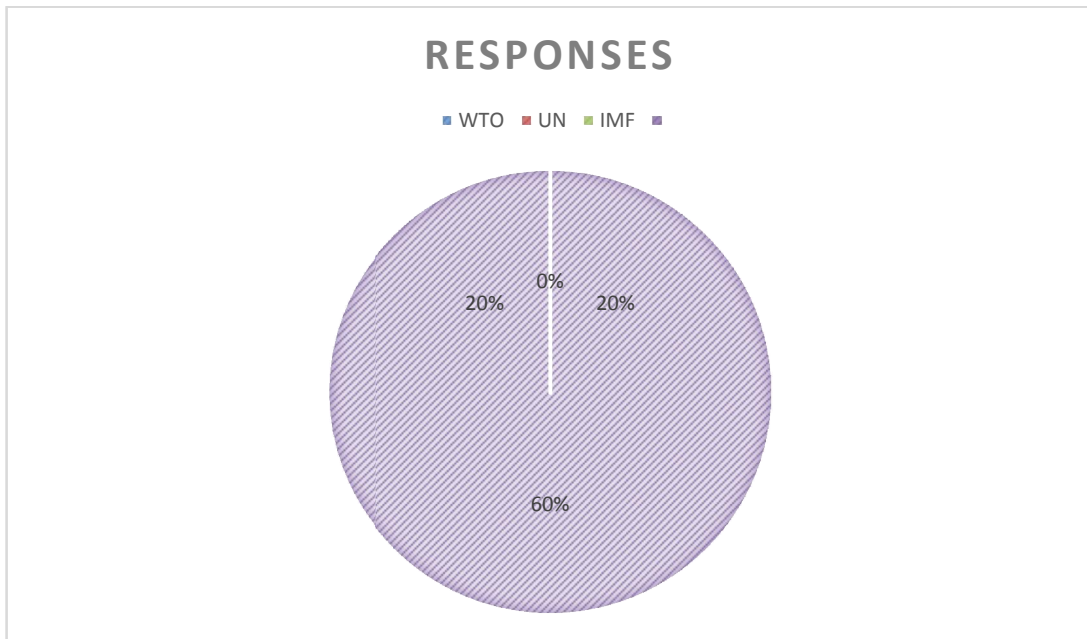


Fig 3 - In your opinion, which regulatory body is most influential in shaping Mahindra Pvt Ltd's international business practices?

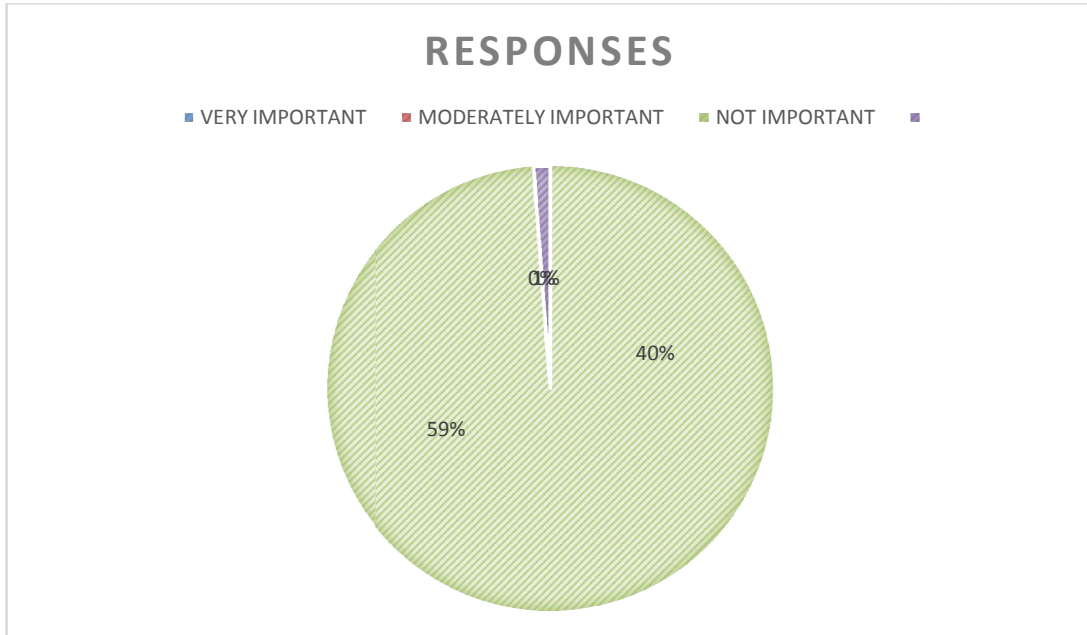


Fig 4 - How important is compliance with international labor laws for Mahindra Pvt Ltd's reputation?

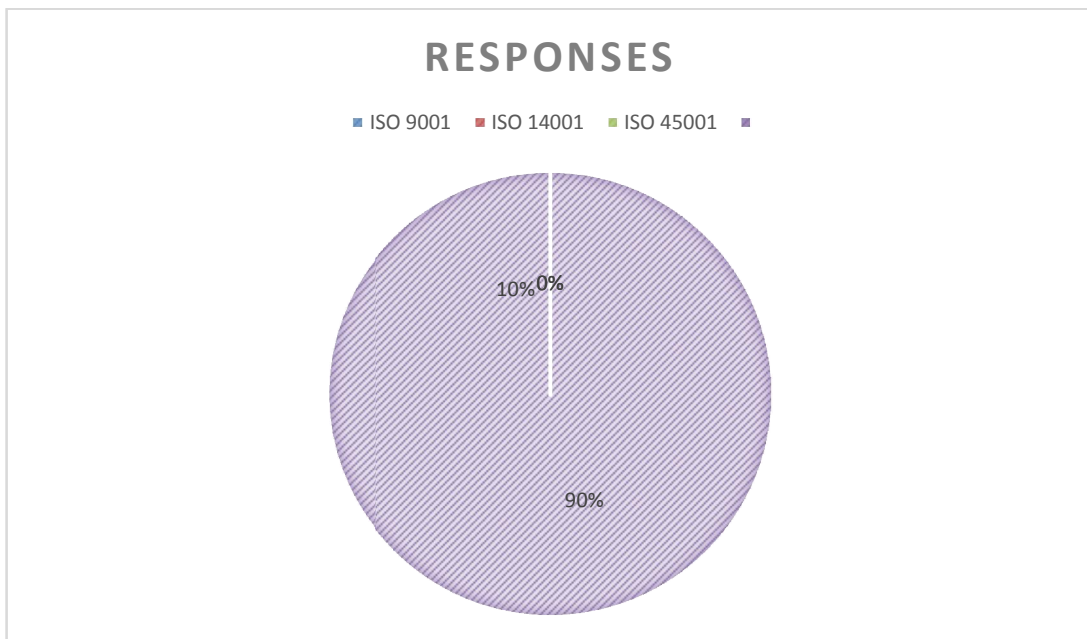


Fig 8 - Which international standard do you believe is crucial for Mahindra Pvt Ltd's product quality?

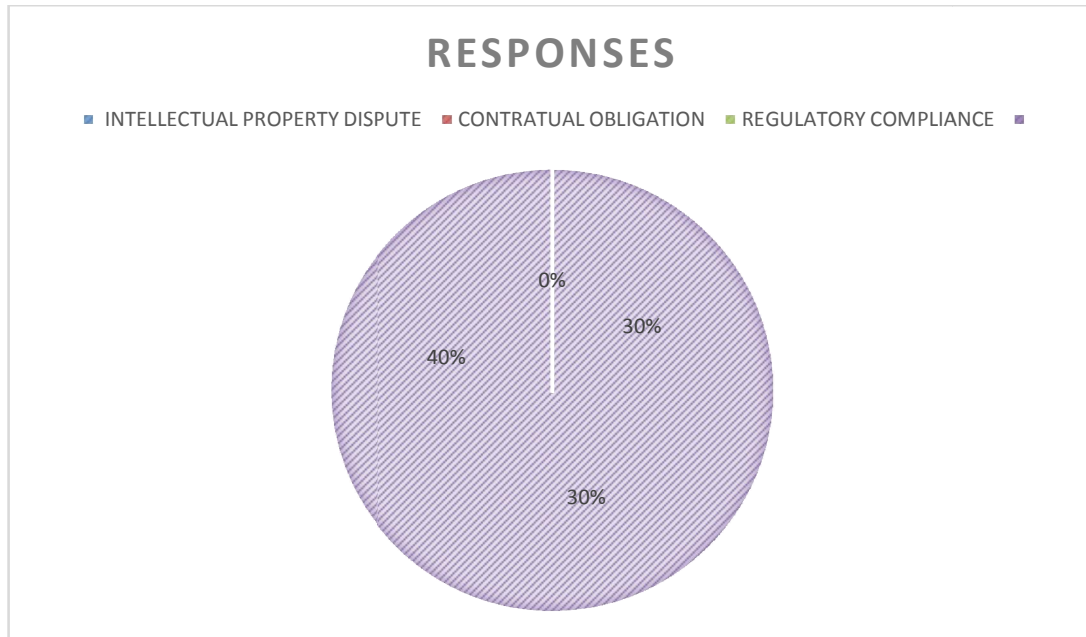


Fig 12 - Which international legal challenge do you think Mahindra Pvt Ltd faces most frequently?
