
- 1. The face pack is providing the Nourishment to the skin.

INGREDIENTS OF FORMULATION-1) MULTANI MITTI-




Figure 2; Multani Mitti

PROCEDURE FOR APPLICATION OF FACE PACK-

- 1. Take few grams of powder mixture made up of milk powder ,Turmeric, Orange peel powder, rice flore, rose water, Multani mitti, and Sandalwood
- 2. To create a smooth paste, add 3-4ml of rose Water or plain cold water. Apply this paste all over your face, give It 10 to 15 minutes to dry.
- 3. Gently scrape pack off skin once Powder has dried, then rinse it off with cold water
- 4. When gently Massaged into the skin for a few minutes, face pack also Functions as a scrub.
- 5. The pack should be applied daily on wet face, Forming a paste of it in water as well as rose water with optimum thickness

METHOD OF EVALUATION-

A) Organoleptic Evaluation-

A number of organoleptic characteristics, including colour, Odour, look, texture, and consistency, were assessed for the Prepared face pack. The senses of touch and sensation were Used to evaluate colour, smell, and texture visually.

B) Rheological Evaluation-

Evaluation of the powder's properties was required. A Number of physical metrics, including angle of repose, bulk Density, tapped density & hausner's ratio, were used to Evaluate sample.

C) Washability-

It was determined how easily a formulation could be wiped Off. After applying a face pack, the skin was carefully Examined to see how easily and thoroughly it could be Washed with regular tap water.

D) Physicochemical evaluation-

Physicochemical parameters were determined, Including the determination of extractive value, ash value, pH and moisture content.

E) Physical evaluation-

The particle size was tested by microscopy Method. The flow property of the dried powder of Combined form was evaluated by performing Angle of Repose by funnel method, bulk density and tapped density By Tapping Method.

F) Phytochemical evaluation-

The aqueous extract of the herbal face pack was Evaluated for the presence of different phytoconstituents as Per the standard procedures.

G) Irritancy test-

Mark an area (1sq.cm) on the left-hand dorsal Surface. Definite quantities of prepared face packs were Applied to the specified area and time was noted. Irritancy, Erythematic, edema, was checked if any for regular Intervals up to 24 hrs and reported.

H) Stability studies-

Stability testing of prepared formulation was Conducted by storing at different temperature conditions for The period of one month. The packed glass vials of Formulation stored at different temperature conditions like, Room temperature and 40C and were evaluated for physical Parameters like color, odour, pH, consistency and feel.

RESULT AND DISCUSSION-

Following evaluation parameters were performed To ensure superiority of prepared face pack.

Morphological Evaluation-

Herbal face pack was evaluated for morphological Parameters showed in the Table 2. The colour of Formulation was pale yellow. The odour of prepared Formulations was pleasant and good acceptable which is Desirable to cosmetic formulations. Texture and smoothness Was acceptable as per requirement of cosmetic Formulations.

We have made a good effort to create a herbal face pack using natural herbal components including rice flour, milk powder, turmeric, sandal wood, saffron, orange peel, and banana peel. We evalu- ated the face packs and discovered that they had good qualities, were not irritating to the skin, and were consistent even after stability storage conditions

. Research has shown that a herbal face pack has the capacity to effectively brighten skin. Because of the product's beneficial effects on people, the entire study is helpful in supporting product claims.
